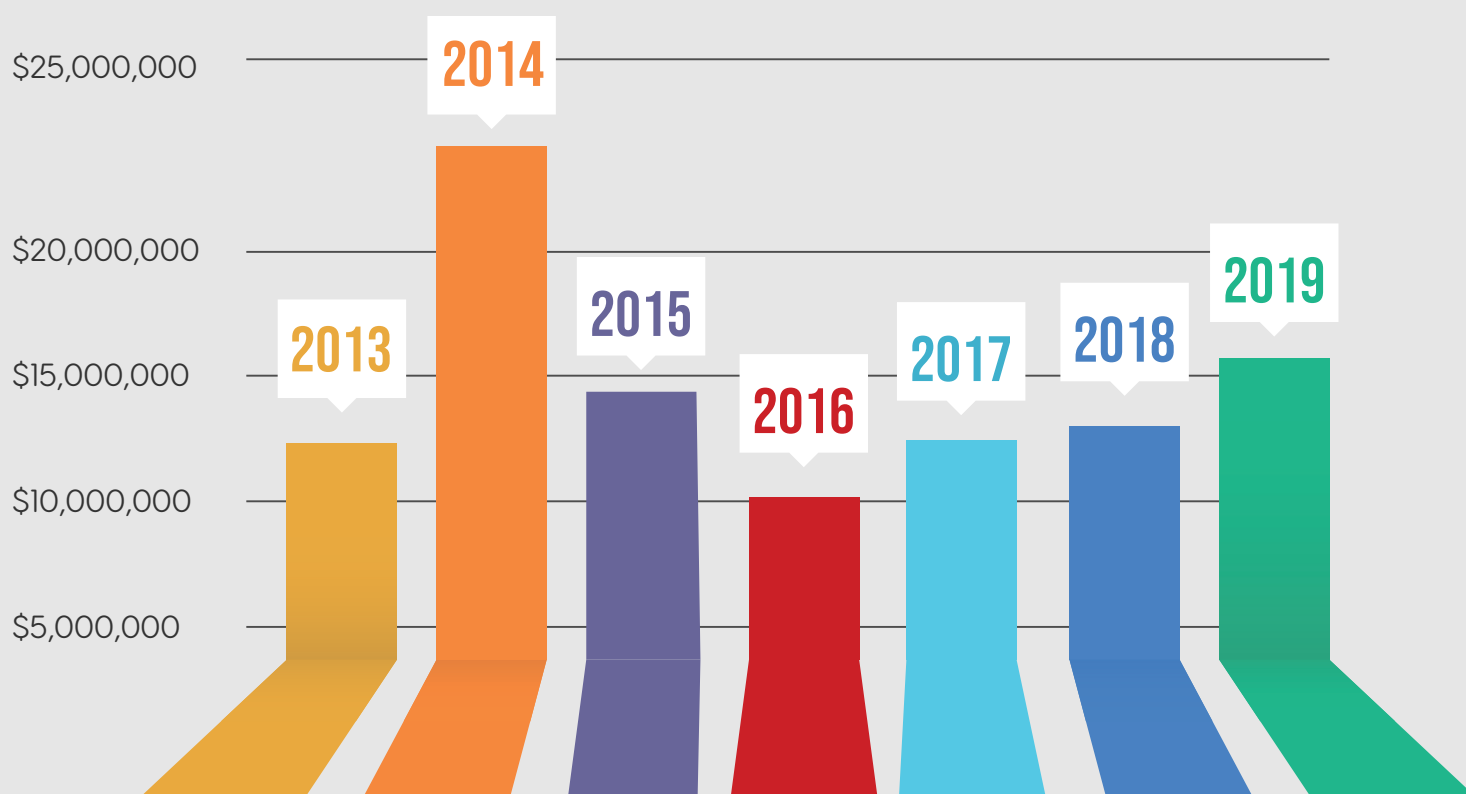

Periodic revisions shall be carried out to make sure that no factors have changed. Shams Al Saduq have a planning of all lifting operations which shall as a minimum ensure that:

- ⦿ All personnel involved with lifting operations are trained and familiarized.
- ⦿ The travel path is clarified and any obstacles are removed before lifting commences
- ⦿ Barricading, signage and or spotter/s are in place to prevent personnel from walking or standing within the lift path or under the load
- ⦿ The lifting operation can be executed safely in relation to simultaneous operations
- ⦿ Lifting equipment is suitable and will be used in accordance with the manufacturer's instructions
- ⦿ The lay down area can accommodate the load in terms of size and weight.

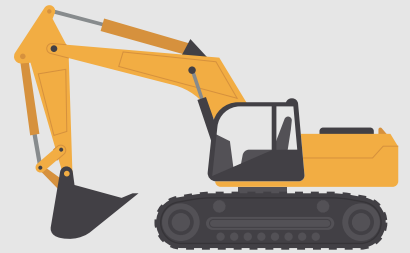
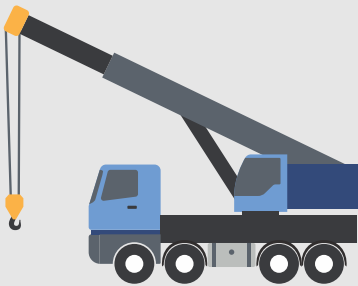

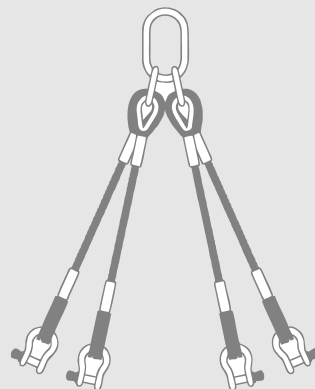

- ⦿ Seat belts shall be worn at all times in equipment and vehicles
- ⦿ Obey posted speed limits and other regulatory signs on site. If no speed limit is posted, the speed limit shall be 10 MPH
- ⦿ Give pedestrians the right of way
- ⦿ Only authorized, properly trained persons may operate Forklifts, Scissor lifts, Cranes, Manlifts, Excavators, Dump trucks or any other of our equipment's
- ⦿ Equipment must not be operated beyond its rated capacity. Rating plates on the machines must be kept legible





PERSONAL SAFETY REQUIREMENTS

All employees must be committed to the following

- ⦿ No one under the age of eighteen (18) shall be permitted on a job site unless accompanied by a supervisor 100% of the time. UNDER NO CIRCUMSTANCES SHALL A PERSON UNDER 18 BE EMPLOYED ON A JOB SITE.

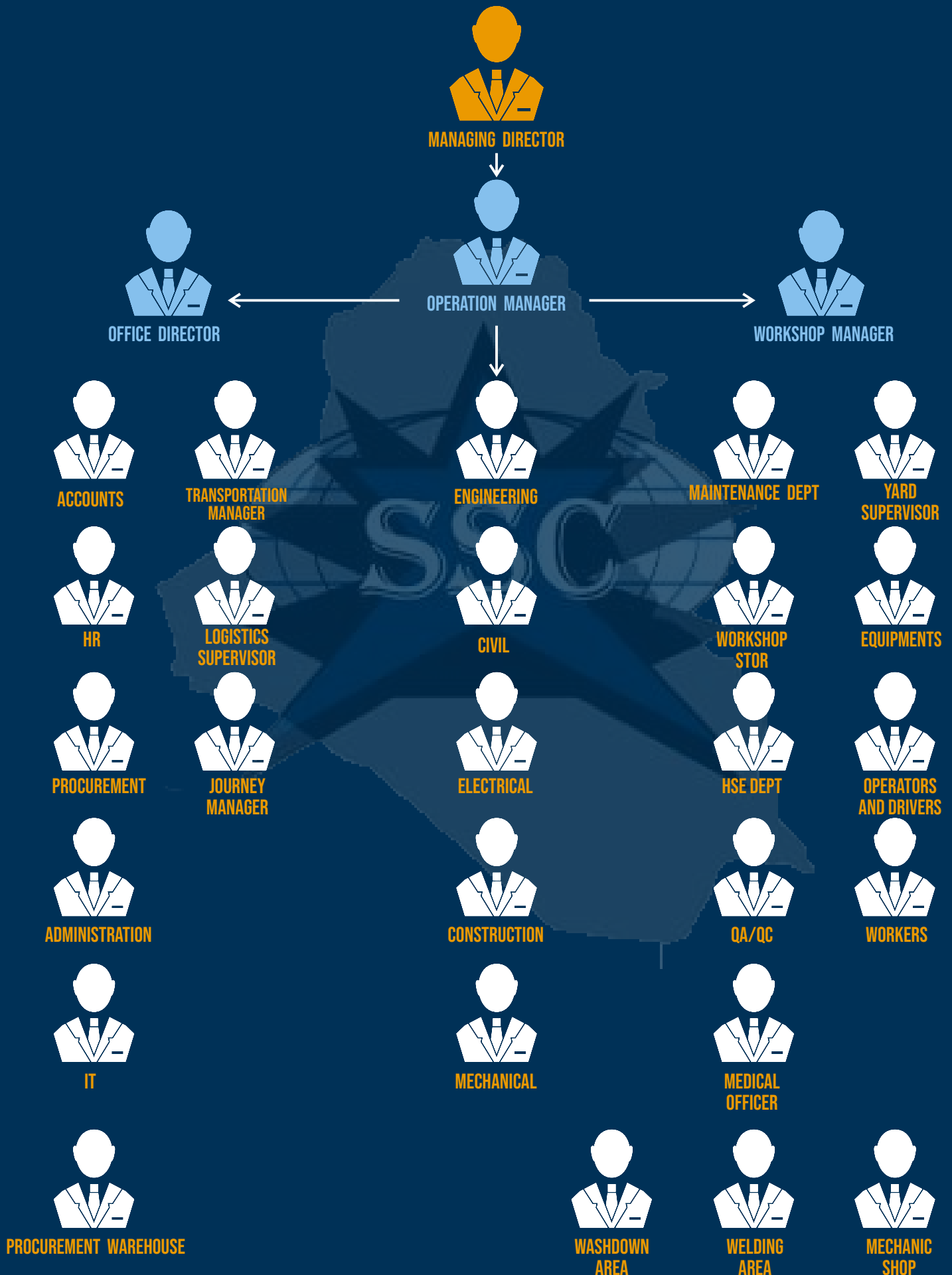
